

# NOTICE OF RACE, NOR-CAL#1

## “MAVERICKS REGATTA”

Saturday Sept. 15, 2007

Location: Pillar Point Harbor at Highway 1 and Capistrano Road, which is 2 miles north of the City of Half Moon Bay. Take Capistrano into the harbor. Turn left on Prospect, left on Broadway, right on Princeton Ave. HMBYC is at the corner of Vassar and Princeton Avenue.

1. RULES: U.S.S.A 2005-2008 as modified by PCISA, ISSA, NOR-CAL sailing and Sailing Instructions at regatta.
  - Each boat will be required to display a sail number.
2. ELIGIBILITY, ENTRY & ENTRY FEE, REGISTRATION
  - The regatta is open to all High School Teams. Teams may enter by registering with HMBYC by September 12, 2007. Fee may be paid on regatta day.
  - Entry Fee: The entry fee is \$25.00 per competitor, Make checks payable to HMBYC. Fee will include Continental breakfast, lunch, dinner, and awards.
  - Schools may enter as many teams as they chose. If your school does not have sufficient sailors to form the necessary teams, we will attempt to "mix and match" sailors from different schools. If your school has more than one team please enter as team 1, 2, 3 etc.
3. BOAT
  - Each entered team is responsible for providing two class legal CFJ one for Division "A" and one for: B" and one class legal set of sails (main and jib) for each division. There will be no formal rotations.
  - A & B divisions will start separately.
  - After two races, time will be allowed (determined by RC) for those who wish to substitute in. This can be done on the water or at the Race Dock adjacent to the race course
4. SAILING INSTRUCTIONS: Will be available during regatta & the skippers meeting
5. PROTESTS: '3 Minute Justice', each party has a SINGLE minute to state their case and the judges have a SINGLE minute to make a decision.
6. SCHEDULE: Saturday
  - 8:30 A.M. Registration begins
  - 9:30 A.M. Skippers meeting
  - 10:30 A.M. Racing begins
  - No races started after 4:30pm
  - 3 Minute Justice Protest
  - Awards
7. MEALS: Included in fee for competitors – Continental Breakfast, Lunch, and Dinner.
  - Non-Competitors meals available for purchase, lunch (\$5) and dinner (\$5)
8. CONDITIONS: Water temperature of 53°F. It is imperative that sailors, coaches and others come properly dressed. Bring appropriate clothing and wear it. *Sailors must be in wetsuits or drysuits. No suit, no sail.*
